



Pandemic Economics: the impact of the COVID-19 pandemic on the Malaysian



- Synopsis

 COVID-19 has had devastating impacts on the Malaysian economy. The sources of damage to the Malaysian economy are twofold: The first is the external, arising from the impacts of the coronavirus abroad; while the second is domestically generated due mainly to earlier nationwide movement restrictions.
- In terms of economic growth, the impacts from the crisis have been severe. The Malaysian economy contracted by 17.1 percent year-on-year in 202020—the steepest amount since the aftermath of the Asian Financial Crisis in 1998.
- The COVID-19 crisis has also deeply affected the Malaysian labour market and Malaysian workers. The unemployment rate is still hovering at multi-decade highs, while marginalised worker groups like women, youth, and lesser-educated workers have been the hardest hit by the COVID-19 crisis.
- There is still room for more fiscal expansion. Due to the unprecedented nature of the COVID-19 crisis and the large distributional impacts, policy action can go even further to alleviating some of these pressures in the immediate-term as well as increasing economic growth and productivity for the longer-term.

Aim


The Special Project (SP) aims at working on research programmes that have the potential to provide solutions to critical national or global issues through high impact research activities.

MAIN CHARACTERISTICS OF SPECIAL PROJECTS

- 1. Act as a precursor to securing substantial external grants
- 2. Targeted at solving real world issues of national/global significance with the potential to create impact.
- 3. Involves the co-creation of research projects via the formulation and implementation of the project together with stakeholders outside academia.
- 4. Led by UM researchers but the project can involve experts from other universities.
- 5. Interdisciplinary research team working on a focused problem/issue
- 6. The research team should demonstrate a good track record in the proposed area of research (papers, expertise, etc.).

FOCUS AREAS



Others

Topics under other government and international policies, roadmaps etc. will also be considered:

- National Fourth Industrial Revolution (4IR) Policy
- Other relevant government policies, plan and road maps
- Sustainable Development Goals (SDG) etc. etc.

If applicable, proposed research should be in line with National Policy on Science, Technology & Innovation (NPSTI), 10-10 Malaysian Science, Technology, Innovation and Economy (MySTIE) Framework.

Main Deliverables of Special Projects

- Secure an external grant in the course of carrying out this project.
- Build strategic partnership with stakeholders.
- Demonstrate a clear pathway towards impact and achievement of the outcomes related to the solutions to the problem identified.
- Scholarly output (high quality publication).
- Patents, other IP, and/or evidence of echnology/product/process development (as applicable).
- Policy papers, guidelines, manuals, artistic/creative work etc. (as applicable).

1. Title

2. Affiliations and contact details of PI and Co-PI (The research team should comprise researchers from different disciplines who can contribute towards addressing a focused research issue.)

3. Stakeholder engagement

- Explain your engagement with stakeholders. Describe who your stakeholders are, how you have engaged with them and the extent that you have engaged with them.
- Roles and contribution of stakeholders in this project.

- **4. Background of research** (Background and purpose: clear and concise description of the research topic. Include a brief summary of the literature citing only seminal, significant, and compelling sources to provide the context for your project and discuss what others have discovered and/or accomplished, the purpose of your research, describe the "so what?"; why the project matters)
- **5. Targeted national/international issue** (What is the national/international issue to be addressed? How do you know that this is an issue? Why is it important to address this issue?)
- **6. Proposed solution** (What is your solution? How do you propose to address this issue? What is the significance of the solution? Benefit? Who will benefit? How? Explain how your proposed solution will address the issue in the immediate, short or long term)

- 7. Objective of research (Specific, Measurable, Attainable, Realistic, Timebound)
- 8. Brief methodology
- 9. Targeted external grant (What external grants and amount do you target for additional funding for your project?)
- 10. Maximum allowable grant from internal grant: RM150,000.00 per project
- 11. Project duration: 2 years
